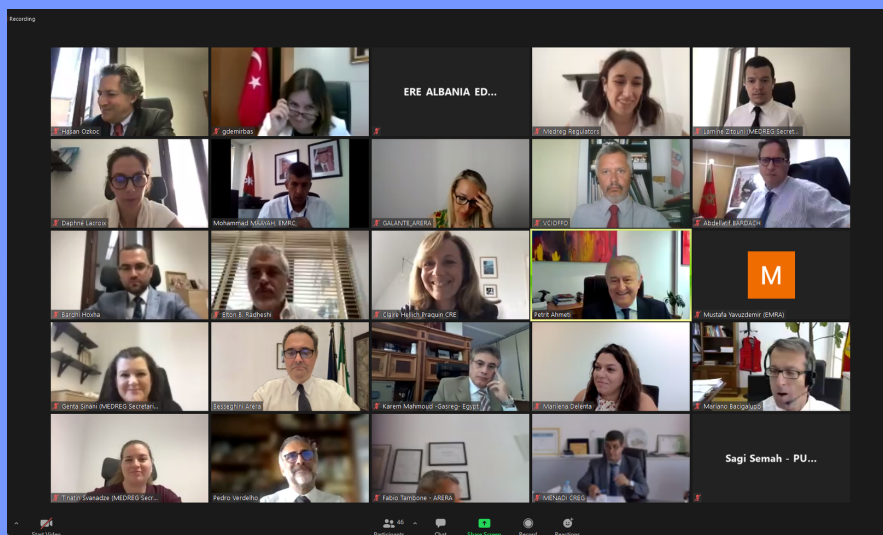
41st Meeting - MEDREG Steering Committee

The 41st Meeting of the Steering Committee of Medreg that took place on June 16, 2021 via the online platform, was led by ERE Chairman Mr. Petrit Ahmeti, in the role of the President of MEDREG. At this meeting, the Directors of the Technical Working Groups (TWGs) presented the key results that shall be submitted. They also announced other activities (support for national reforms, Seminars) that shall be organized in the course of this year.



GENERAL ASSEMBLY OF MEDREG

The 31st Meeting of the General Assembly of Medreg was held on June 29, 2021 by ERE Chairman Mr. Petrit Ahmeti, who is also the President of MEDREG. The Agenda of the Assembly comprised the technical activities of the working groups for gas and electricity, the institutional procedures regarding renewable energy and customer protection. One of the aspects that was discussed by the permanent working groups was related to the security of supply in the Mediterranean countries, the distribution network development planning, drafting and implementation of regulations for the gas sector, analysis of gas infrastructure to improve flexibility and the interaction of energy systems, as well as the role of digitalisation and its impact on customer issues.





Memorandum of cooperation ERE - Faculty of Law (UT)

ERE Chairman Mr. Petrit Ahmeti held a meeting with representatives from the Faculty of Law of the University of Tirana. In this meeting it was signed the Memorandum of Cooperation, in order to increase and develop the capacity and provide services between these two institutions, implementing the policies of ERE and Faculty of Law (UT) curricula. The parties aim to cooperate and contribute in areas of common interest, such as consulting domestic and European Union legislation, human resource management, organizing trainings, various projects, work practices, awareness campaigns, etc., through the exchange of experiences and ideas with experts from ERE.
