**BEGINNING THE PROCEDURES OF LICENSING “PTA” (POWER TRADE ALBANIA) COMPANY IN ELECTRICITY TRADING ACTIVITY**

On the basis of articles 8 point 2 letter “a”; 9 and 13 point 1, letter “d” of Law no. 9072, date 22.05.2003, “*For Electricity Sector*”, as amended, articles 4, point 1, letter “g”; 8 and 10 point 3 of the “Regulation for the Procedures of Licensing, Modification, Full/Partial Transferring and License Renewal”, approved with Board of Commissioner Decision No. 108, of date 09.09.2008, article 18, point 1, letter “a”, of ERE-s Practice and Procedure Regulations, approved with Board of Commissioner Decision no. 21, date 18.03.2009, as amended, ERE-s Board of Commissioners, on its meeting of date 07.07.2014, after reviewed the application presented by “PTA” (Power Trade Albania) company, and the report of License and Market Monitoring Office as well as Legal and Customer Protection Office to be licensed in the electricity trading activity of this company,

**Observed that:**

The application of “PTA” (Power Trade Albania) company partially completes the requirements provided by ERE in the Regulation for the procedures of licensing, modification, full/partial transferring and license renewal as follows:

- The application format (article 9, point 1) is submitted and completed correctly.
- Legal, administrative and ownership documentation (article 9, point 2) is submitted and completed partially. (There are missing the documentations from the Prosecution and from the Court that the director of the company is not included in a penal process and also the construction, functioning and administrative structure of the company).
- Financial and fiscal documentation (article 9, point 3) is submitted and completed correctly.

- The technical documentation (article 9, point 4.10 letters “a”, “b” and “c”) is submitted and completed partially. (There is missing the financial capital statement made available for realising this activity, (article 9, point 4.10 letter “b”)

For the missing documentation the company will be informed according to the “*Regulation for the Procedures of Licensing, Modification, Full/ Partial Transferring and License Renewal*”, article 10, point 10 and article 11, point 1, to be submitted them at ERE within the deadlines.

For all the above mentioned ERE’s Board of Commissioner,

**Decided:**

1. To begin the procedures of reviewing the application of “PTA” (Power Trade Albania) company, for licensing in Electricity Trading activity.
2. Licensing and Market Monitoring Office is charged to notify the applicant for ERE-s Board of Commission decision.
