SOME AMENDMENTS AND ADDITIONS IN THE REGULATIONS FOR ALLOCATING THE INTERCONNECTION CAPACITIES

On the basis of article 9, Law no.9072, of date 22.05.2003, "For Electricity Sector", as amended, Chapter 11, of the Regulations for Allocating the Interconnection Capacities, approved with decision no. 13, of date 22.02.2011 of ERE-s Board of Commissioners and article 26 of ERE-s Practice and Procedure Regulations, approved with ERE-s Board of Commissioner decision no. 21, of date 18.03.2009, ERE-s Board of Commissioner on its meeting of date 07.07.2014, after reviewed the report prepared by the Working Group regarding TSO company proposal for some amendments and additions on the "Regulations for Allocating the Interconnection capacities", approved with decision No. 13 of date 22.02.2011.

Decided:

- 1. To approve TSO company proposal according to the amendments attached to this decision.
- 2. The Legal and Customer Protection Office shall notify TSO company, for ERE-s Board of Commissioner Decision.

The daily auction in point 5.1 will be as follows:

"The daily auction"

The daily available capacity, for any limit and direction, for day D, is composed from the amount of unallocated capacity in the relevant monthly auction, with the "returned" capacity declared from the respective participants that will not be used in day D.

The procedure of calculating and allocating the daily transmitting capacity is:

Until 10:00 every day, the market participants that has won the right to transmit in anual/monthly auction, should declare the capacity quantity in ME, separately for every limit and direction, that they have planned to use in day D+2,

Until 11:00 every day, TSO (Transmission System Operator) publishes in its website, and informs the market participants for the available capacity for day D+2 for every limit and direction, and exchanges the relevant information with the neighbour TSO-s regarding the "returned" and available capacity for day D+2,

In the interval 12:00 - 14:00 every day, TSO performs the auction procedure accepting electronically by NOVITÀ platform the requests of the market participants for the transmitting capacity for day D+2, in conformity with the respective notification made from its part,

- Until 15:00 every day, TSO makes the capacity allocation, defines the winners and the price of the auction, according to the same procedure that is actually followed by TSO in the annual/daily

capacity allocated for day D+2.

- The procedure of daily allocation for Sunday, Monday and Tuesday is realised on Thursday.

If day D is official holiday, the procedure will be performed in the preceding working day.

The invoice for the daily auction will be prepared on monthly basis by the end of month during which

the capacity is used. The payment of the invoice is made based on the payment procedure of the

transmission service. TSO company has the right to intervene in the bank guarantee of the market

registration in case of not paying the month invoice and if the amount in the bank guarantee does not

cover the payment for the capacity usage to exclude the participant in the daily auction until it meets

the financial obligation toward TSO company."
