



***DECISION***

***No. 73 of date 22.08.2014***

**FOR**

**BEGINNING THE PROCEDURE OF LICENSING “SA’GA-MAT” COMPANY, IN ELECTRICITY GENERATION ACTIVITY FROM “GERMAN 1”, “GERMAN 2”, “GERMAN 3” AND “GERMAN 4” HPP-S.**

On the basis of articles 8 point 2 letter “a”; 9 and 13 point 1, letter “a”, of Law no. 9072, date 22.05.2003, “*For Electricity Sector*”, as amended, articles 4, point 1, letter “a”; 5 point 1 letter “a”; 13 and 14 point 1 of the “Regulation for the Procedures of Licensing, Modification, Full/Partial Transferring and License Renewal”, approved with Board of Commissioner Decision No. 108, of date 09.09.2008, ERE-s Board of Commissioners, on its meeting of date 22.08.2014, after reviewing the application submitted by “SA’GA-MAT” company, and the report of License and Market Monitoring Office as well as Legal and Customer Protection Office for licensing this company in electricity generation activity, with a total capacity of 4.98 MW

**Observed that:**

The application of “SA’GA-MAT” company, fully completes the requirements provided by ERE in the Regulation for the procedures of licensing, modification, full/partial transferring and license renewal as follows:

- The application format (article 9, point 1) is submitted and completed correctly.
- Legal, administrative and ownership documentation (article 9, point 2) is submitted and completed correctly.
- Financial and fiscal documentation (article 9, point 3) is submitted and completed correctly.

- Technical documentation (*Article 9, point 4.1.1; point 4.1.2; 4.1.3; 4.1.4; 4.1.5*) are completed correctly.

For all the above mentioned ERE-s Board of Commissioners,

**Decided:**

To begin the procedures of reviewing the application of “SA’GA-MAT” company, for licensing in electricity generation activity with a total capacity of about 4.98 MW from “German 1”( with 1.2 MW capacity) , “German 2”( with 1.680 MW capacity), “German 3”( with 1.29 MW capacity) and “German 4”( with 0.81 MW capacity) .
