**FOR**

**RENEWING THE LICENSE OF “GSA” COMPANY, IN ELECTRICITY  
QUALIFIED SUPPLIER ACTIVITY APPROVED WITH BOARD OF  
COMMISSIONERS DECISION NO.102, OF DATE 21.12.2009.**

On the basis of article 9, article 13 point 1, article 45, point 3 and 4 of Law No. 9072, date 22.05.2003, “*For Electricity Sector*”, as amended, articles 4, point 1, letter “P”; 5, point 1, letter “P”; 12; 13; 14 point 1 and article 16 of the “*Regulation for the procedures of licensing, modification, full/partial transferring and license renewal*”, approved with Board of Commissioners Decision No. 108 of date 09.09.2008, as amended, ERE-s Board of Commissioners, on its meeting of date 16.09.2014, after reviewing the application of “GSA” company for renewing the license of electricity qualified supplier and the information of License and Market Monitoring Office as well as Legal and Customer Protection Office,

**Observed that:**

The application of “GSA” company, fully completes the requirements provided by ERE in the Regulation for the procedures of licensing, modification, full/partial transferring and license renewal as follows:

- The application format (article 9, point 1) is submitted and completed correctly.
- Legal, administrative and ownership documentation (article 9, point 2) is submitted and completed correctly.
- Financial and fiscal documentation (article 9, point 3) is submitted and completed correctly.

- Specific data according to the type of the License (article 9 point 4/9 letters a, b and c) are fully completed.

For all the above mentioned ERE-s Board of Commissioners,

**Decided:**

1. To renew the license of “GSA” company in Electricity Qualified Supplier activity, approved with Board of Commissioners Decision No.102, of date 21.12.2009.
2. This decision enters into force on 21.12.2014 and extend its effects for a period of 5 years.
3. License and Market Monitoring Office is charged to notify the applicant for ERE-s Board of Commissioners decision.
