**BEGINNING THE PROCEDURES OF LICENSING “EFT ALBANIA”
COMPANY IN ELECTRICITY QUALIFIED SUPPLIER ACTIVITY**

On the basis of articles 3, point 31; 8 point 2, letter “a”; 9; 13 point 1 letter “ç”; 45 points 3, 4, 48, of Law No. 9072, date 22.05.2003, “*For Electricity Sector*” as amended, articles 4 point 1 letter “P”; 5 point 1 letter “P” 8; 10, point 1 and 3, of the “*Regulation for the procedures of licensing, modification, full/partial transferring and license renewal*”, approved with Board of Commissioners Decision No. 108 of date 09.09.2008, article 18, point 1, letter “a”, of “*ERE-s Practice and Procedure Regulations*”, approved with Board of Commissioner Decision, No. 21, of date 18.03.2009, as amended, ERE-s Board of Commissioners, on its meeting of date 29.09.2014, after reviewing the application submitted by “EFT Albania” company, and the report of License and Market Monitoring Office as well as Legal and Customer Protection Office on licensing this company in Electricity Qualified Supplier activity,

Observed that:

The application of “EFT Albania” company partially completes the requirements provided by ERE in the “*Regulation for the procedures of licensing, modification, full/partial transferring and license renewal*” as follows:

For the General Documentation

- Article 9, point 1
The application format: is completed correctly
- Article 9, point 2
Legal, administrative and ownership documentation is partially completed. (It is absent the partnership deed for this company.)
- Article 9, point 3
Financial and fiscal documentation is fully completed

For Electricity Qualified Supplier Activity

- Article 9 , point 4/9, letter a
(It is absent electricity quantity provided for trade in the next five years)
- Article 9 , point 4/9, letter b
(It is absent the voltage level and the way to realise the measurement for the qualified customers.
- Article 9 , point 4/9, letter c
It is absent the financial capital declaration available to realise this activity.

For all the above mentioned ERE-s Board of Commissioners,

Decided:

1. To begin the procedures of reviewing the application of **“EFT Albania” company**, for licensing in Electricity Qualified Supplier activity.
2. License and Market Monitoring Office is charged to notify the applicant for ERE-s Board of Commissioners decision.
