FOR

BEGINNING THE PROCEDURES FOR LICENSING "UKKO" COMPANY IN ELECTRICITY GENERATION ACTIVITY FROM PHOTOVOLTAIC PLANTS.

On the basis of articles 8 point 2 letter "a"; 9 and 13 point 1, letter "a", of Law no. 9072, date 22.05.2003, "For Electricity Sector", as amended, articles 4, point 1, letter "a"; 5 point 1 letter "a"; 13 and 14 point 1 of the "Regulation for the Procedures of Licensing, Modification, Full/Partial Transfering and License Renewal", approved with Board of Commissioners Decision No. 108, date 09.09.2008, ERE-s Board of Commissioners, on its meeting of date 29.09.2014, after reviewing the application submitted by "UKKO" company, and the report of License and Market Monitoring Office as well as Legal and Customer Protection Office for licensing this company in electricity generation activity from photovoltaic plants,

Observed that:

The application of "UKKO" company partially completes the requirements provided by ERE in the "Regulation for the procedures of licensing, modification, full/partial transfering and license renewal" as follows:

- The application format (article 9, point 1) is submitted and completed correctly.
- Legal, administrative and ownership documentation (article 9, point 2) is submitted and completed correctly.
- Financial and fiscal doccumentation (article 9, point 3) is submitted and completed correctly.

- Technical documentation (Article 9, point 4.4.1; point 4.4.2; 4.4.3;) are submitted and completed correctly.
- Technical-economical documentation (Article 9, point 4.4.4) is partially completed: It is absent the business plan.
- Permit from other institutions.(Article 9, point 4.4.5) is partially completed: It is absent the environmental permit from respective bodies.
- For the missing documentations, the company will be notified that according to the "Regulation for the Procedures of Licensing, Modification, Full/Partial Transfering and License Renewal", article 10, point 10 and article 11, point 1, to submit them at ERE, within the deadlines.

For all the above mentioned ERE-s Board of Commissioners,

Decided:

- 1. To begin the procedures of reviewing the application of "UKKO" company, for licensing in electricity generation activity from photovoltaic plants.
- 2. License and Market Monitoring Office is charged to notify the applicant for ERE-s Board of Commissioner decision.

This decision enters immediately into force.
