On the basis of articles 8 point 2, letter "ll", 9 and 39 of Law No. 9072, date 22.05.2003 "For Electricity Sector" as amended, article 3 point 1 letter "f", of Law No. 138/2013, date 02.02.2013, "For Energy Renewable Resources"; article 9 point 1 and point 2 letter "a" of the Regulations and Procedures for Electricity Generation Certification from Renewable Resources approved with Board of Commissioner Decision No. 9, of date 21.02.2007, the Board of Commissioners on its meeting of date 06.10.2014, after reviewing the application submitted by "SA'GA-MAT" company on qualifying the generation plant from "German 1", "German 2", "German 3" and "German 4" HPP-s with a total capacity of 4.98 MW
