BEGIN THE PROCEDURES FOR QUALIFYING THE GENERATION PLANT OF "FATLUM" COMPANY FOR "PERROLLAJ" HPP AS ENERGY RENEWABLE RESOURCE

On the basis of articles 8 point 2 letter "ll"; 9 and 39, of Law no. 9072, date 22.05.2003, "For Power Sector", as amended, article 3, point 1, letter "f"; of Law No. 138/2013"For Energy Renewable Resources", as amended, article 9, point 1, and 2, letter "a" of the Regulations and Procedures for Electricity Generation Certification from Renewable Resources, approved with Board of Commissioners Decision No. 9, of date 21.02.2007, ERE-s Board of Commissioners, on its meeting of date 01.12.2014, after reviewing the application submitted by "FATLUM" company, and the report of License and Market Monitoring Directory as well as Legal and Customer Protection Directory for qualifying the generation plants of "FATLUM" company for "PERROLLAJ" HPP with total capacity of 0,5 MW, as energy renewable resource.

Observed that:

The application of "FATLUM" company fully completes the requirements provided by ERE in the *Regulation and Procedures for Electricity Generation Certification from Renewable Resources* as follows:
