BEGINNING THE PROCEDURES TO LICENSE "FUTURE ENERGY AL" COMPANY IN ELECTRICITY QUALIFIED SUPPLIER ACTIVITY

On the basis of articles 3, point 31; 8 point 2, letter "a"; 9; 13 point 1 letter "ç"; 45 points 3, 4 and 48, of Law Nr. 9072, date 22.05.2003, "For Power Sector" as amended, articles 4 point 1 letter "f"; 5 point 1 letter "f" 8; 10, point 1 and 3, of the "Regulation for the procedures of licensing, modification, full/partial transferring and license renewal as follows", approved with Board of Commissioners Decision No. 108 of date 09.09.2008, article 18, point 1, letter "a", of "ERE-s Practice and Procedure Regulations", approved with Board of Commissioners Decision, No. 21, of date 18.03.2009, as amended, ERE-s Board of Commissioners, on its meeting of date 01.12.2014, after reviewing the application submitted by "FUTURE ENERGY AL" company, and the report of License and Market Monitoring Directory as well as Legal and Customer Protection Directory to license this company in Electricity Qualified Supplier activity,

Observed that:

The application of "FUTURE ENERGY AL" company partially completes the requirements provided by ERE in the "Regulation for the procedures of licensing, modification, full/partial transferring and license renewal" as follows:

For the General Documentation

- Article 9, point 2
 Legal, administrative and ownership documentation is partially completed.
 (The documentation from the Prosecution and Court that the person is not involved in a penal process started from the judiciary is missing.)

• Article 9, point 3

Financial and fiscal documentation is partially completed.

(The documentation for attesting the Tax payment is missing.)

• Article 9, point 4/9, letter a, b and c are partially submitted and completed.

For the missing documentations, the company will be informed that according to the "Regulation for the Procedures of Licensing, Modification, Full/Partial Transferring and License Renewal", article 10, point 10 and article 11, point 1, to submit them at ERE, within the

deadlines.

Decided:

1. For beginning the procedures to review the application of "FUTURE ENERGY AL" company, for licensing in Electricity Qualified Supplier

activity.

2. Legal and Market Monitoring Directory is charged to notify the applicant
