APPROVING THE AGREEMENT FOR ELECTRICITY SUPPLY BETWEEN KESH (ALBANIAN POWER CORPORATION) COMPANY, (WHOLESALE PUBLIC SUPPLIER) AND OSHEE (DISTRIBUTION SYSTEM OPERATOR) COMPANY (RETAIL PUBLIC SUPPLIER) FOR 2015

Based on Law 9072, date May.22.2003 “*On Power Sector*” as amended article 8 point 2, article 9 and article 26 point 1, the Electricity Market Model point 4.12 and 4.13 letter “A”, point 2, approved with Council of Ministers Decision no.338, date March.03.2008, as amended, Electricity Market Rules point V.1, approved with ERE Board of Commissioners Decision, no. 68 date June.23.2008, as amended, ERE Board of Commissioners on their February.04.2015 meeting, after being introduced with KESH company proposal Prot. no. 7627 date October.29.2014 as well as the report prepared by ERE Technical Directorates, on the Agreement “For electricity supply between KESH company (Wholesale Public Supplier) and OSHEE company (Retail Public Supplier) for 2015

Observed that:

- The parties of this agreement are legitimated companies to sign this contract for electricity transmission system knowing that:
- “KESH (Albanian Power Corporation)” company is licensed for electricity Wholesale Public Supply activity with ERE Board of Commissioners decision, No.10 date February.06.2014.
- “OSHEE (Distribution System Operator)” company is licensed for electricity Retail Public Supplier activity with ERE Board of Commissioners decision, No.97 date October 27.10.2014.

2. The provisions of this contract are in harmony with Electricity Market Model approved with Council of Ministers Decision no.338 date March.19.2008, the Market Rules approved with Board of Commissioners Decision no. 68, date June.23.2008, as amended.

3. The Market Model gives ERE the attribute of the authority that has the right to approve this contract category.

For all of the above mentioned,

Decided:

- To approve the agreement “For Electricity Supply” between KESH company / Wholesale Public Supplier and OSHEE company / Retail Public Supplier, for 2015.
- Legal and Market Monitoring Directory is charged to inform the parties for this decision.

This decision enters immediately into force and extends its effects from January.01.2015 until December.31.2015.
