**DECISION**

**No.134, of November.11.2015**

**ON**

**AN AMENDMENT IN DECISION NO. 131, OF OCTOBER.31.2015  
“FOR APPROVING THE AUCTION RULES OF THE  
COORDINATED AUCTION OFFICE FOR SOUTH EAST EUROPE  
(SEE CAO)” VERSION 1.2**

Based on Law 43/2015 articles 16 and 18, “*On Power Sector*”, Law no. 8485 article 112 of “Administrative Procedures Code of the Republic of Albania”, of May.12.2008, as amended, “ERE Practice and Procedure Regulation” article 16, point 3, *approved with decision No.21 of March.18.2009*, as amended, ERE Board on their November.11.2015 meeting, after reviewing the request of TSO company on ERE Board decision no.131 of October. 31.2015 on “*Approving the Auction Rules of the Coordinated Auction Office for South East Europe (SEE CAO)*” version 1.2 and the report prepared by the Legal Directory;

**Decided:**

1. Decision no. 131, of October.31.2015 “*On Approving the Auction Rules of the Coordinated Auction Office for South East Europe (SEE CAO)*” version 1.2”, shall be made the following amendments:

a) Point 2 shall be amended: 2. The legal effects to implement decision No.156 of December.01.2014 the “*Auction Rules of the Coordinated Auction Office for South East Europe (SEE CAO)*” are those defined by SEE CAO.

b) It is added point 4 with the content as follows:

“Interconnection auction capacities for the borders are excluded according to SEE CAO procedure, for the remaining part of 2015, TSO company beginning from October.31.2015, shall perform in conformity with the “*Allocation regulation of interconnection capacities*”, approved with ERE Board of Commissioners Decision No.140, of November.22.2013”.

2. Legal and Customer Protection Directory shall inform TSO company for ERE Board Decision.

This decision enters immediately into force.
