DECISION

No. 15, of date 19.01.2017

ON

OPENING THE PROCEDURES TO MODIFY THE LICENSE OF "KOMP ENERGJI" COMPANY, ORDER NO. 253, SERIES T14P, APPROVED WITH ERE BOARD DECISION NO. 102, OF DATE 07.11.2014, ON ELECTRICITY TRADING

Based on articles 16; 20, letter "b" and 43, point 1, of Law no. 43/2015, "On Power Sector", article 113 of Law no. 44/2015 "Administrative Procedures Code in the Republic of Albania"; Council of Ministers Decision No. 840, of date 11.06.2008 "On defining the Contracting Authority to give with concession "Vinjoll" HPP; articles 10 and 15 of the "Regulation on the Procedures and Terms for License Issue, Modification, Transferring, Renewal and License Removal on Power Sector", approved with ERE Board decision no. 109, of date 29.06.2016, article 19, point 1, letter "a" of the "Regulation on ERE organization, operation and procedures" approved with ERE Board decision no. 96, of date 17.06.2016, ERE Board on their 19.01.2017 meeting, after reviewing the report of License and Market Monitoring Directory regarding the license modification in electricity trading activity of "Komp Energii" company,

Observed that:

- "Komp Energji" company is licensed in Electricity Trading activity for a 30 year period, with license no. 253, Series T14P, approved with ERE Board Decision no.102, of date 07.11.2014.
- Referring to the official letter Protocol no. 791, of date 11.11.2016, signed by the concession of "Komp Energji" administrator and the administrator of the "Hidropowerplant Construction" concession is required the substitute of the "Komp Energji" concessionary name, with the name of "Hidropowerplant Construction" concessionary, only for Electricity Generation license.
- Since Electricity Trading license is mainly connected with HPP generation activity "Hurdhas 1", "Hurdhas 2" and "Hurdhas 3", it is necessary to make the modification of Electricity Trading license in the favor of "Hidropowerplant Construction" concessionary.

Decided:

- 1. To open the procedure to modify license no. 253, Series T14P, approved with ERE Board decision, no. 102, of date 07.11.2014, on Electricity Trading kept by "Komp Energji" concessionary.
- 2. License and Market Monitoring Directory shall inform the applicant for ERE Board decision.

This decision enters immediately into force. This decision is published in the Official Gazette.

This decision may be appealed at Tirana Administrative Court, within 30 calendar days from the publication in the Official Gazette
