## ON APPROVING THE FIX ELECTRICITY TARIFF, FOR 2015, THAT WILL BE PAYED TO ELECTRICITY GENERATORS FROM THE HYDRO POWER PLANTS

On the basis of Law 9072, of May.22.2003, "For Power Sector" as amended, articles 9, 26 point 1; Law no 138/2013 "For energy renewable resources" as amended, article 15, point 3, Law no. 8485, of May.12.2008 for "Administrative Procedures Code for the Republic of Albania", as amended, Ministerial Council Decision no.125, of February.11.2015 article 111 "For approving the methodology to determine the fix tariff for electricity during 2015, that will be payed to electricity generators from the hydro power plants"; ERE Practice and Procedure Regulations, approved with ERE Board of Commissioners Decision No. 21, of March.18.2009, as amended; ERE Board of Commissioners, on their February.16.2015 meeting, after reviewing the report submitted by Tariff and Prices Directory for the fix electricity sale tariff from electricity generators for 2015,

#### Decided:

- 1. The fix electricity tariff, that will be payed to electricity generators from the hydro power plants for 2015, should be 7.636 ALL /kWh.
- 2. Decision no.5, date January.26.2007, of ERE-s Board of Commissioners "For approving the methodology to determine electricity sale price for the licensees for electricity generation from existing HPP-s with installed capacity up to 10 MW", and Decision no. 24, date April.11.2007, of ERE-s Board of Commissioners "For approving the methodology to determine the unique price of electricity sale for the licensees for electricity generation from new HPP-s with installed capacity up to 10 MW" are abrogated.
- **3.** KESH company and electricity Producers from hidro power plants are charged to implement this decision.

This decision enters immediately into force and extends its effects from 01.01.2015 until on 31.12.2015.
