LICENSING "BALLENJA POWER MARTANESH" COMPANY IN ELECTRICITY TRADING ACTIVITY

Based on article 16; 37, point 2 letter "d" and article 110 of Law No. 43/2015 "On Power Sector", articles 4, point 1, letter "g"; 5, point 2; 13 of the "Regulation for the Procedures of Licensing, Modification, full/partial Transferring and Licenses Renewal", approved with ERE Board Decision No. 108, of date 09.09.2008, ERE Board on their 12.04.2016 meeting, after reviewing the application submitted by "BALLENJA POWER MARTANESH" company and the report of License, Market and Licensee Monitoring Directory to license this company in electricity trading activity;
