ON

BEGINNING THE PROCEDURES TO LICENSE "DEVOLL HYDROPOWER" COMPANY IN ELECTRICITY GENERATION ACTIVITY FROM "BANJË" HPP WITH INSTALLED CAPACITY 73 000 KW AND "MOGLICË" HPP WITH INSTALLED CAPACITY 182 500 KW (TOTAL INSTALLED CAPACITY 255 500 KW)

Based on articles 16; 37, point 2 letter "a" and 110 of Law No. 43/2015 "On Power Sector", articles 4, point 1, letter "a"; 5, point 1 letter "a"; 10 point 3 of the "Regulation for the Procedures of License, Modification, full/partial Transferring and Licenses Renewal", approved with ERE Board decision, No. 108, of date 09.09.2008 and article 18 point 1 letter "a" of ERE Practice and Procedures Rules, approved with ERE Board decision no. 21 of date 18.03.2009, as amended, ERE Board on their 12.04.2016 meeting, after reviewing the application submitted by "Devoll Hydropower" company, and the report of License and Market Monitoring Directory for licensing this company in electricity generation activity from "Banjë" and "Moglicë" HPP-s

Observed that:

The application of "Devoll Hydropower" company, partially completes the requirements provided by ERE in the "Regulation for the procedures of licensing, modification, full/partial transferring and licenses renewal" as follows:

- The application form (article 9, point 1, letter "a", "b" and "c") is completed correctly;
- Legal, administrative and ownership documentation (article 9, point 2 letter "a", "b", "c", "d", "e", "f", "g") is completed correctly;

- Financial and fiscal documentation (article 9, point 3 letter "b", "c" and "d") is completed correctly;
- Technical-economic documentation (article 9, points 4.1.1; 4.1.2; 4.1.3; 4.1.4 and 4.1.5), is completed correctly.

For the missing documentation that has to do with:

• Financial and fiscal documentation (article 9, point 3 letter "a"), the company shall be informed that according to the "Regulation for the Procedures of Licensing, Modification, full/partial Transferring and Licenses Renewal", article 10, point 10 and article 11, point 1, to submit them at ERE, within the defined deadline. For all of the above mentioned, ERE Board,

Decided:

- 1. To begin the procedures of licensing "Devoll Hydropower" company, in electricity generation activity from "Banjë" HPP with installed capacity 73 000 KW and "Moglicë" HPP with installed capacity 182 500 KW (total installed capacity 255 500 KW).
- 2. License, Market and Licensee Monitoring Directory shall inform the applicant for ERE Board Decision.
