DECISION

No.47 Date, April.17.2015

FOR BEGINNING THE PROCEDURES TO LICENSE "MESOPOTAM ENERGJI" COMPANY, IN ELECTRICITY GENERATION ACTIVITY FROM "DRIZA" HPP WITH TOTAL CAPACITY OF 3.408 MW.

Based on Law No.9072 date May.22.2003 "On Power Sector" as amended articles 8 point 2 letter "a"; 9 and 13 point 1, letter "d", the "Regulation for the Procedures of Licensing, Modification, full/partial Transferring and Licenses Renewal "article 4, point 1, letter "g"; 5 point 2; 8, 10/3; ", approved with Board of Commissioners Decision No. 108, date September.09.2008, ERE Board of Commissioners on their April.17.2015 meeting, after reviewing the application submitted by "MESOPOTAM ENERGJI" company, and the report of License and Market Monitoring Directory as well as Legal and Customer Protection Directory to license this company in electricity generation activity from "Koxheraj" HPP,

Observed that:
