Based on Law No.9072, date May.22.2003 "On Power Sector" as amended article 8 point 2 letter "a"; 9 and 13 point 1, letter "d", the "Regulation for the Procedures of Licensing, Modification, full/partial Transferring and Licenses Renewal article 4, point 1, letter "g"; 5 point 2; 8,13 and 14 point 1, approved with Board of Commissioners Decision No.108, date September.09.2008, ERE Board of Commissioners on their April.23.2015 meeting, after reviewing the application submitted by "Green Energy Trading Albania" company and the report of License and Market Monitoring Directory as well as Legal and Customer Protection Directory to license this company in electricity trading activity,
