No.5 Date, February.02.2015

FOR BEGINNING THE PROCEDURES TO LICENSE " ROBERTO OIL" COMPANY IN THE ACTIVITY OF ELECTRICITY QUALIFIED SUPPLIER

Based on Law 9072, date May.22.2003, "On Power Sector" (as amended) articles 3, point 31; 8 point 2, letter "a"; 9; 13 point 1 letter "c"; 45 points 3, 4 and 48, of the "Regulation for the procedures of licensing, modification, full/partial transferring and license renewal" articles 4 point 1 letter "f"; 5 point 1 letter "f" 8; 10, points 1 and 3, Commissioners Decision No. approved with Board of 108 date September.09.2008, "ERE Practice and Procedure Regulation" article 18, point 1, letter "a", approved with Board of Commissioners Decision, No. 21, date March.18.2009, as amended, ERE Board of Commissioners, on its February.02.2015 meeting, after reviewing the application submitted by "Roberto Oil" company, and the report of License and Market Monitoring Directory as well as Legal and Customer Protection Directory for licensing this company in the activity of Electricity Qualified Supplier,

Observed that :

The application of "Roberto Oil company " partially completes the requirements provided by ERE in the "Regulation for the procedures of licensing, modification, full/partial transferring and license renewal" as follows:

For the General Documentation

• Article 9, point 1

The application format, is incomplete

• Article 9, point 2. *Legal, administrative and ownership documentation* is partially completed. It is absent the certification from the public prosecutor office that the manager of the company is not in a penal process and also is absent administrative organizational structure of the company.

- Article 9, point 3. Financial and fiscal documentation is fully completed.
- Article 9, point 4/9, letter a. It si absent the electricity quantity that is expected for supplying the qualified clients for the next five years.
- Article 9, point 4/9, letter b. It is absent the voltage level and the way of realising the measuring for the qualified clients.
- Article 9, point 4/9, letter c. It is absent the financial capital declaration set available for realizing this activity.
- For the missing documentation, according to the "Regulation for the Procedures of Licensing, Modification, Full/Partial Transferring and License Renewal " article 10 point 10 and article 11 point 1, the company will be informed to submit these documents at ERE, within the deadlines.

For all of the above mentioned ERE Board of Commissioners,

Decided:

- **1.** To begin the procedures of reviewing the application of "Roberto Oil company.", for licensing in the activity of Electricity Qualified Supplier.
- **2.** License and Market Monitoring Directory is charged to inform the applicant for ERE Board of Commissioners decision.

This decision enters immediately into force.
