DECISION

No. 67 Date May.11.2015

FOR BEGINNING THE PROCEDURES TO LICENSE "GAMA ENERGY" COMPANY, IN ELECTRICITY TRADING ACTIVITY.

Based on Law No.9072, date May.22.2003 "On Power Sector" as amended articles 8 point 2 letter "a"; 9 and 13 point 1, letter "d", the "Regulation for the Procedures of Licensing, Modification, full/partial Transferring and Licenses Renewal" articles 4, point 1, letter "g"; 5 point 2, 8 and 10 point 1 and 3, approved with Board of Commissioners Decision No. 108, date September.09.2008, ERE Board of Commissioners on their May.11.2015 meeting, after reviewing the application submitted by "GAMA ENERGY" company, and the report of License and Market Monitoring Directory as well as Legal and Customer Protection Directory to license this company in electricity trading activity,

Observed that:

The application of "GAMA ENERGY" company, completes the requirements provided by ERE in the "Regulation for the procedures of licensing, modification, full/partial transferring and licenses renewal" as follows:
