DECISION

No. 73, of date 27.05.2016

ON

OPENING THE PROCEDURE TO LICENSE "REKA ENERGY" COMPANY, IN ELECTRICITY GENERATION ACTIVITY FROM "ZAJE" HPP WITH CAPACITY 220 KW, "TURAJ" HPP WITH CAPACITY 320 KW, "XHAFERAJ-MESHTEKEN" HPP WITH CAPACITY 3680 KW, "NOVOSEJ" HPP WITH CAPACITY 220 KW, AND "KOLLOVOZ" HPP WITH CAPACITY 1500 KW (TOTAL CAPACITY 5940 KW)

Based on articles 16; 37, point 2 letter "a" and article 110 of Law No. 43/2015, "On Power Sector", articles 4, point 1, letter "a"; 5, point 1 letter "a"; 10 point 3 of the "Regulation on the Procedures of Licensing, Modification Full/Partial Transferring and Licenses Renewal", approved with ERE Board Decision, No. 108, of date 09.09.2008 and article 18 point 1 letter "a" of ERE Practice and Procedures Rules, approved with ERE Board decision no. 21 of date 18.03.2009, as amended, ERE Board on their 27.05.2016 meeting, after reviewing the application submitted by "REKA ENERGY company, and the report of License and Market Monitoring Directory to license this company in electricity generation activity,

Observed that:

The application of "REKA ENERGY" company, partially completes the requirements provided by ERE in the Regulation for the procedures of licensing, modification, full/partial transferring and license renewal as follows:

- The application form (article 9, point 1 letters "a", "b" and "c") is completed correctly;
- Legal, administrative and ownership documentation (article 9, point 2, letters "a", "b", "c", "d", "e", "f", "g",) is completed correctly;
- Financial and fiscal documentation (article 9, point 3, letter "d") is completed correctly;

• Technical-economic documentation (article 9, points 4.1.3; 4.1.4 letters "a", "b" and "c"; 4.1.5 letters "b" and "c"), is completed correctly.

For the missing documentation that has to do with:

- The Financial Statement; the documentation for liquidating the taxes and the documents that certify the ability and the financial support of the applicant (article 9 point 3 letters "a", "b" and "c")
- The technical data for each HPP; technical data for the transforming block and the connection with the system and the approval of the connection point (article 9 points 4.1.1, 4.1.2, 4.1.4 letter "d" and 4.1.5 letter "a"), the company shall be informed that based on the "Regulations for the Procedures of License, Modification, Full/Partial Transferring and License Renewal", article 10, point 10 and article 11, point 1, to submit them at ERE within the defined deadlines.

For all of the above mentioned ERE Board,

Decided:

- 1. To open the procedures of licensing "REKA ENERGY" company, in electricity generation activity from "Zaje" HPP with capacity 220 KW. "Turaj" HPP with capacity 320 KW, "Xhaferaj-Meshteken" HPP with capacity 3680 KW, "Novosej" HPP with capacity 220 KW, "Kollovoz" HPP with capacity 1500 KW (total capacity 5940 KW).
- 2. License, Market and Licensee Monitoring Directory shall inform the applicant for ERE Board decision.

This decision enters immediately into force This decision is published in the Official Gazette.
