



## DECISION

No. 75 Date June.08.2015

FOR

**APPROVING THE MODIFICATION OF LICENSE NO. 138, SERIES PV11K FOR ELECTRICITY GENERATION FROM “PELLGUT TË OKSHTUNIT” HPP, WITH INSTALLED CAPACITY 31.489 MW, OF “DITEKO” COMPANY, APPROVED WITH ERE BOARD OF COMMISSIONERS DECISION NO. 114 DATE NOVEMBER .16.2011**

Based on Law 9072 date May.22.2003, “*On Power Sector*” as amended, articles 9 and 19, “*Electricity Generation License*” points 2.3 and 2.4 No. 138, Series PV11K”; the “*Regulation for the procedures of licensing, modification, full/partial transferring and licenses renewal*” articles 13, 14 point 2; 15 points 1, 2/b, 3 and 4; approved with Board of Commissioners Decision No. 108, date September.09.2008, ERE Board of Commissioners on their June.08.2015 meeting, after reading the report of License and Market Monitoring Directory as well as Legal and Customer Protection Directory,

### Observed that:

The application of "DITEKO" company, fully completes the legal requirements provided by the “*Regulation for the procedures of license, modification, full/partial transferring and licenses renewal*” as follows:

- **Article 15, point 4, letter “a”**: The written information where are explained the reasons for license modification request, is completed correctly.

**Article 15, point 4, letter “b”**: It is submitted in the written form the decision of the governing bodies of the licensee, that express their intention to require the license modification.

- It is submitted the new project, approved by MEI (Ministry of Energy and Industry) with document Prot.no. 131/8, date July.08.2014, for an optimal usage of “Zalli i Okshtunit” river flows, where are made some modifications in the scheme of using the cascade that is composed of 7 HPP-s and not 11 HPP-s.

For all of the above mentioned, ERE Board of Commissioners,

**Decided:**

1. The license modification of “DITEKO” company, no. 138, Series PV11K, for Electricity Generation from “Pellgut të Okshtunit” HPP with total installed capacity 31.489 MW, approved with Board of Commissioners Decision No 141 date November.16.2011.
2. Installed capacity of “Pellgut te Okshtunit” HPP-s, from 31.489 MW to become 33.28 MW, according the labels and the capacities as follows : “Borove” HPP with installed capacity 1.92 MW, “Zabzun” HPP with installed capacity 0.3 MW, “Sebisht + Prodan 1” HPP with installed capacity 3.8 MW, “Prodan 2” HPP with installed capacity 1 MW, “Okshtun Ekologjik” HPP with installed capacity 0.45 MW, “Okshtun + Ternove + Lubalesh 1”HPP with installed capacity 14.95 MW and “Lubalesh 2 + Gjorice” HPP with installed capacity 10.86 MW.
3. License and Market Monitoring Directory shall inform the applicant foe ERE Board of Commissioners decision.

This decision enters immediately into force.
