## DECISION

### No. 79, Date June.08.2015

## FOR

#### TRANSFERRING ELECTRICITY TRADING LICENSE FROM "WATER SUPPLY AND SEWERAGE TIRANA" COMPANY TO "LANABREGAS" HPP

Based on Law No.9072 date May.22.2003 "On Power Sector" as amended 9; 19 and 20 point 1, the "Regulation for the Procedures of Licensing, Modification, full/partial Transferring and Licenses Renewal" article 17, ERE Board of Commissioners on their June.08.2015 meeting, after reviewing the request of "Water Supply and Sewerage Tirana" company, licensed in Electricity Trading activity with ERE Board of Commissioners Decision no.99, and the report prepared by License and Market Monitoring Directory as well as Legal and Customer Protection Directory,

### Observed that:

- 1. The application of "Water Supply and Sewerage Tirana" company to transfer the Electricity Trading license, fully completes the requirements provided by ERE in the regulation for the procedures of licensing, modification, full/partial transferring and licenses renewal as follows;
  - □ The application form according to article 9, point 1, (article 17 point 4 letter "a") is submitted and completed correctly.
  - □ The written information where are explained the reasons for the license transferring. (article 17 point 4 letter "b") is submitted and completed correctly.
  - □ The written decision of the governing bodies of the licensee that express their interest to require the license transferring (article 17 point 4 letter "c") is submitted and completed correctly.

- 2. The application of "Lanabregas" HPP to transfer Electricity Trading license fully completes the requirements provided by ERE in the regulation for the procedures of licensing, modification, full/partial transferring and licenses renewal as follows:
  - □ The application form (article 9, point 1) is submitted and completed correctly.
  - □ Legal, administrative and ownership documentation (article 9, point 2) is submitted and completed correctly.
  - □ Financial and fiscal documentation (article 9, point 3) are submitted and completed correctly.

For all of the above mentioned ERE Board of Commissioners,

## Decided:

- 1. To transfer Electricity Trading license, no. 147, Series TPV11SH approved with ERE Board of Commissioners Decision no. 99 of September.13.2013, from "Water Supply and Sewerage" Tirana company, to "Lanabregas" HPP.
- 2. Legal and Customer Protection Directory is charged to inform "Water Supply and Sewerage Tirana" and "Lanabregas" HPP for ERE Board of Commissioners Decision.

This decision enters immediately into force.
