ON
BEGINNING THE PROCEDURES TO LICENSE
"LENGARICA & ENERGY" COMPANY IN ELECTRICITY
GENERATION ACTIVITY FROM "LENGARICA" HPP WITH
INSTALLED CAPACITY 8.94 MW

Based on Law No. 43/2015 articles 2, letter "c"; 16; 37, point 2 letter "a" and 39 point 3 "On Power Sector", the "Regulation for the Procedures of Licensing, Modification, Full/Partial Transferring and Licenses Renewal" articles 4, point 1, letter "a"; 5, point 1 letter "a"; 10 point 3, approved with ERE Board of Commissioners Decision, No. 108, of September.09.2008 and ERE Practice and Procedure Rules article 18 point 1 letter "a", approved with ERE Board of Commissioners decision no. 21 of March.18.2009, as amended, ERE Board on their June.30.2015 meeting, after reviewing the application submitted by "LENGARICA & ENERGY" company, and the report prepared by License and Market Monitoring Directory as well as Legal and Customer Protection Directory to license this company in electricity generation activity from "Lengarica" HPP;
