No. 57, of date 29.04.2016

ON OPENING THE PROCEDURES TO LICENSE "DAAB ENERGY GROUP" COMPANY IN ELECTRICITY GENERATION ACTIVITY FROM "DOBRENJË - TOMORRICË" HPP WITH INSTALLED CAPACITY 2400 KW

Based on articles 16; 37, point 2 letter "a" and article 110 of Law No. 43/2015 "On Power Sector", articles 4, point 1, letter "a"; 5, point 1 letter "a"; 10 point 3 of the "Regulation on the Procedures of Licensing, Modification, full/partial Transferring and Licenses Renewal", approved with ERE Board Decision No. 108, of date 09.09.2008 and article 18 point 1 letter "a" of ERE Practice and Procedure Rules, approved with ERE Board decision no. 21 of date 18.03.2009, as amended, ERE Board, on their 29.04.2016 meeting, after reviewing the application submitted by "Daab Energy Group" company and the report of License and Market Monitoring Directory for licensing this company in electricity generation activity from "Dobrenje-Tomorrice" HPP,

Observed that:

The application of "Daab Energy Group" company, partially completes the requirements provided by ERE in the "Regulation for the procedures of licensing, modification, full/partial transferring and licenses renewal" as follows:
