ON

THE REQUEST OF “ÇEZ TRADE ALBANIA” COMPANY TO BEGIN THE LICENSE WITHDRAWAL: NO.91 SERIES TE10P AND NO. 92 SERIES FP10K GIVEN WITH ERE’S BOARD OF COMMISSIONER DECISIONS No.1 AND No.2 OF DATE 20.01.2010 ON ELECTRICITY TRADING ACTIVITY AND ELECTRICITY QUALIFIED SUPPLIER

On the basis of articles 8 point 2 letter “a”; 9; 18 point 1 letter “e”, Law No. 9072, date 22.05.2003 “For Electricity Sector ” as amended, articles 34 and 35 Law No. 7850, of date 29.07.1994 “the Civil Code in the Republic of Albania”, and pursuant to article 5 of “Regulation for License Withdrawal Procedures”, ERE’s Board of Commissioners, on its meeting of date 21.03.2014, after being introduced with the report prepared by ERE’s Technical Offices, regarding the license withdrawal of CEZ Trade Albania company,

Observed that:

- “CEZ Trade Albania” company with ERE’s Board of Commissioner decision no.1, of date 20.01.2010, is provided with license no. 91 Series TE10P, in the Electricity Trading activity available for a period of 5 years.
- “CEZ Trade Albania” company with ERE’s Board of Commissioner decision no. 2 of date 20.01.2010, is provided with license no. 92 Series FP10K, in the Electricity Qualifies Supplier activity available for a period of 5 years.
- ERE with decision no.13 of date 03.03.2014, approved TSO request to resolve the “Market Participation Agreement”, connected between CEZ Trade Albania in the quality of Electricity Trader and TSO company – TO (Transmission Operator) and the request of TSO company to settle the “Market Participation Agreement”, concluded between CEZ Trade Albania company in the quality of Electricity Qualified Supplier and TSO company – TO.
- CEZ Trade Albania company, with its document Prot no. 12/26, of date 26.12.2013, (deposited in TSO) informs that this company is subject to the liquidation process.

- “CEZ Trade Albania” company with document Prot no. 1058, of date 27.12.2013, has requested from ERE the beginning of the procedures to withdraw the above mentioned licenses since it is a company in liquidation and wants to be out of the electricity market with its will.

For all the above mentioned, ERE’s Board of Commissioners

Decided:

1. The beginning of the procedures to review CEZ Trade Albania company request, to withdraw the license no. 91 Series TE10P , approved by ERE’s Board of Commissioner Decision no. 1, of date 20.01.2010, on Electricity Trading activity available for a period of 5 years.
2. The beginning of the procedures to review CEZ Trade Albania company request, to withdraw the license no. 92 Series FP10K, approved by ERE’s Board of Commissioner Decision no. 2 of date 20.01.2010, on Electricity Qualified Supplier activity, available for a period of 5 years.
3. The Licensing and Market Monitoring Office shall notify CEZ Trade Albania company, for ERE’s decision.

This decision enters immediately into force.
