

Rules ‘On defining the data form and the procedure for the supplier’s access to the data of the Electricity Distribution Operator’

**Article 1**

**Authority**

This regulation is drafted implementing article 69, of Law no. 43/2015 “On Power Sector”, Law no. 9501 dated 03/04/2006 “On the ratification of the Treaty for the establishment of Energy Community”.

**Article 2**

**Object**

1. These rules define the procedures and requests for information, regarding the on time access of DSO data on electricity consumption in a transparent and non-discriminatory way.
2. These rules also defines in details Distribution System Operator obligations, regarding the availability of the data related to electricity consumption from end-use customers and other necessary issues for their publication.

**Article 3**

**Access of the data**

1. DSO shall ensure as part of the provided Service, the access on the electricity consumption data from the Customers.
2. The Operator/DSO shall ensure this service by a dedicated website, but even by the customer care center, where the Supplier submits a request for the data. The consumption history is available through the website or by a document available at the Customer Care Offices or any other form of sending the data, including but not being limited, by phone messages and other forms accessible by the public.
3. The historic information (that includes the annual consumption for not less than a period that includes the last five years, is a right guaranteed for all the suppliers from the legislation. Furthermore, the data on monthly basis of the information are ensured by the DSO to the Supplier.
4. DSO ensures to the supplier even the electricity data on hourly basis for all the customers when the metering equipment permits such a calculation.
5. The Distribution System Operator shall deliver to the Supplier the required data, according to this regulation not later than 1 (one) calendar day after receiving the request from the Supplier. The request form shall be according to Annex No.1 of this Regulation.

6. The Supplier requiring the above mentioned data, shall have signed before a confidentiality agreement, guaranteeing fulfillment of the legal obligations, including in special the legislation on the Protection of Personal Data.

#### **Article 4**

##### **Other obligations**

1. DSO shall establish the codes which define the rules of using and enter on the defined data according to these rules.
2. The supplier shall not have direct access to the access programs, but shall have access by personal password to the electricity consumption data from DSO by using a common portal for all the suppliers.
3. On each case, this portal shall ensure the individual electronic identification of the supplier that accesses the data, to which corresponds a unique code that shall be generated for any registered supplier and has a confidentiality contract and agreement with DSO.
4. For all the cases when required by the Supplier, DSO shall provide the data according to the format on hourly, monthly, quarterly and annual data.
5. The information on this data, is updated maximally 5 calendar days after the consumption/last registered day, when the metering equipment permit the hourly measures
6. On any other case, the update of the data shall correspond to the latest month registered on measuring.

#### **Article 5**

##### **Interpretation**

1. In the event that an issue is not handled in this Regulation, ERE shall decide case by case and shall issue the instructions according to the respective requirements in conformity with the legislation in force.
2. **The terms and definitions used on this regulation shall have the meaning defined on law or. 43/2015 “On Power Sector”**

#### **Article 6**

##### **Amendments of the regulation**

These rules are object of review and amendment with ERE Board decision, and in conformity with ERE practice and procedures rules.

**Article 7**  
**Entry into force**

1. This Regulation “On defining the data form and the procedure for the access of the supplier to the data of the Distribution System Operator” enters into force, not later than 12 months from the approval of these rules by ERE.
3. Until the entry into force of these rules, on each case DSO shall ensure this access to the Supplier according to other forms provided on this regulation.
