



DECISION

No. 44 of date 13.05.2014

ON

**THE COMPLAINT OF CEZ SHPËRNDARJE COMPANY IN
TEMPORARY ADMINISTRATION ON DECISION NO. 27 OF DATE
31.03.2014 "ON APPROVING THE CONTRACT FOR THE METER
VERIFICATION WHEN INTRODUCED FOR THE FIRST TIME IN
THE MARKET AND/OR WHEN PUT FOR THE FIRST TIME IN USE;
THE PERIODICAL INSPECTION FOR VERIFYING THE METER
ACCURACY AND ELECTRICITY MEASURING, TESTING AND
SEALING SYSTEM AS WELL AS THEIR MAINTENANCE "**

On the basis of article 9 Law No. 9072, date 22.05.2003, "For Electricity Sector", as amended and article 16 point 3 of ERE's Practice and Procedure Regulation, approved with Board of Commissioner Decision no.21, of date 18.03.2009, as amended, ERE's Board of Commissioners, on its meeting of date 13.05.2014, after reviewing the complaint of CEZ Shpërndarje company regarding decision no.27, of date 31.03.2014 "For approving the Contract on the meter verification when introduced for the first time in the market and/or when put for the first time in use; the periodical inspection for verifying the meter accuracy and electricity measuring, testing and sealing system as well as their maintenance",

Observed that:

- CEZ Shpërndarje company is notified for decision no. 27, of date 31.03.2014, by the official document Prot no. 288/1, on 01.04.2014.
- The complaint as quoted above is sent to ERE with the official document Prot no. 3727/1, on 28.04.2014.
- The legal basis for submitting this complaint is referred to article 16 point 3 of ERE's Practice and Procedure Regulations in which it is defined that:

"For the normative acts, each party involved in the process may submit to ERE a request to review Board of Commissioner decision within 5 working days from the date of receiving the notification for Board decision. The request for decision review shall be obligatorily accompanied with new evidences for the request which is thought that can lead the Board in a new decision. ERE will handle the request for decision review within 30 calendar days"

following the same process that served even for the decision approval. The request for decision review does not suspend the implementation of decision except of the cases when the Board of Commissioners decides differently.”

For all the above mentioned ERE’s Board of Commissioners,

Decided:

1. The rejection of CEZ Shpërndarje company complaint for decision no.27, of date 31.03.2014 “For approving the contract on the meter verification when introduced for the first time in the market and/or when put for the first time in use; the periodical inspection for verifying the meters accuracy and the electricity measuring, testing and sealing system as well as their maintenance”.
2. Legal and Customer Protection Office shall notify the complaining company CEZ Shpërndarje company, and GMO (General Metrology Office) for ERE’s Board of Commissioner decision.

This decision enters immediately into force.
