BEGINNING THE PROCEDURES OF LICENSING "KOMP.ENERGJI" COMPANY, IN ELECTRICITY TRADING ACTIVITY

On the basis of articles 8 point 2 letter "a"; 9 and 13 point 1, letter "d" Law no. 9072, date 22.05.2003, "For Electricity Sector", as amended, articles 4, point 1, letter "g"; 8 and 10 point 3 of the "Regulation for the Procedures of Licensing, Modificaion, Full/Partial Transfering, and License Renewal", approved with Board of Commissioner Decision No. 108, of date 09.09.2008, article 18, point 1, letter "a", of ERE-s Practice and Procedure Regulations, approved with Board of Commissioner Decision no. 21, of date 18.03.2009, as amended, ERE-s Board of Commissioners, on its meeting of date 22.08.2014, after reviewing the application submitted by "KOMP.ENERGJI" company, and the report of License and Market Monitoring Office as well as Legal and Customer Protection Office for licensing this company in electricity trading activity,

Observed that:

- Financial and fiscal documentation is partially completed: It is incomplete letter a : The documentation for paying the taxes, is out of the deadline defined in article 8, point 3, of the "Regulation for the Procedures of Licensing, Modification, Full/Partial Transferring and License Renewal".)

• **Technical documentation** (article 9, point 4.10 letter "a", "b" and "c") is completed correctly.

For the missing documentations, the company will be informed that according to the "Regulation for the Procedures of Licensing, Modification, Full/Partial Transfering and License Renewal", article 10, point 10 and article 11, point 1, to submit them at ERE, within the deadlines.

For all the above mentioned ERE-s Board of Commissioners,

Decided:

- **1.** To begin the procedures of reviewing the application of "KOMP.ENERGJI" company, for licensing in Electricity Trading acticity.
- **2.** License and Market Monitoring Office is charged to notify the applicant for ERE-s Board of Commissioner decision.
