



***DECISION***

***No. 72 of date 22.08.2014***

ON

**BEGINNING THE PROCEDURES OF QUALIFYING THE GENERATION PLANT OF “KOMP.ENERGJI” COMPANY FOR “HURDHAS 1”, “HURDHAS 2” AND “HURDHAS 3” HPP-S AS ENERGY RENEWABLE RESOURCE .**

On the basis of articles 8 point 2 letter “ll”; 9 and 39, of Law no. 9072, date 22.05.2003, “*For Electricity Sector*”, as amended, article 3, point 1, letter “P”; of Law No. 138/2013“*For Energy Renewable Resources*”, as amended, article 9, point 1, and 2, letter “a” of the Regulations and Procedures of Electricity Generation Certification from Renewable Resources, approved with Board of Commissioner Decision No. 9, date 21.02.2007,, ERE-s Board of Commissioners, on its meeting of date 22.08.2014, after reviewing the application submitted by “KOMP.ENERGJI” company, and the report of License and Market Monitoring Office as well as Legal and Customer Protection Office for qualifying the generation plants of “Komp.Energji” company for “Hurdhas 1”, “Hurdhas 2” and “Hurdhas 3” with total installed capacity 4.21 MW, as energy renewable resource.

**Observed that:**

- The application of “KOMP.ENERGJI” company, fully completes the requirements provided by ERE in the *Regulation for the Procedures of Electricity Generation Certification from Renewable Resources* as follows:

- **Article 7, point 1, letters “a”, “b”, “c”, “d”**  
General description of the plant.

This information is provided accurate and complete.

- **Article 7, point 2, letters “a”, “b”, “c”, “d”**

The following graphical documentation, choreography, general plane, functional scheme etc.

This information is submitted correctly.

- **Article 7 point 3, letter “a“, “b“, “c“**  
Plant description.

This documentation is given accurate and complete.

For all the above mentioned, ERE-s Board of Commissioners,

**Decided:**

1. To begin the procedures of qualifying the generation plant of “Komp.Energji” company for “Hurdhas 1”, “Hurdhas 2” and “Hurdhas 3” HPP-S as energy renewable resource with a total installed capacity of 4.21 MW
2. License and Market Monitoring Office is charged to notify the applicant for ERE-s Board of Commissioner decision.
