



DECISION

ON

**APPROVING THE SHARES TRANSFER OF OSHEE COMPANY
(BEFORE KNOWN AS CEZ SHPËRNDARJE COMPANY), FROM CEZ
COMPANY TO THE MINISTRY OF ECONOMIC DEVELOPMENT,
TRADE AND ENTREPRENEURSHIP**

On the basis of Law no. 9072, date 22.05.2003, “For Electricity Sector”, as amended, Annex 2 of Law no. 114/2014, date 31.7.2014 “To approve the agreement for settling the negotiations between the Republic of Albania and CEZ company”, after the official letter no.4189/4, date 15.9.2014 of Energy and Industry Ministry, ERE-s Board of Commissioners after reviewing the report prepared by Legal Office,

Considering that:

- Electricity Distribution Operator (OSHEE) Company, known before as CEZ Shpërndarje company, is privatized by law no. 10116, of date 23.4.2009 “To approve the selling contract for 76 percent of Distribution System Operator (DSO) company shares between Economy, Trade and Energy Ministry of the Republic of Albania and ÇEZ company ”;
- With law no. 114/2014, of date 31.7.2014 it is approved the Agreement to settling the negotiations between the Republic of Albania and CEZ company;
- On the basis of Annex 2, of this Agreement , OSHEE sh.a (known before as CEZ Shpërndarje company)shares in the ownership of CEZ company, will pass to the Albanian state, because above all, ERE will issue a decision that approves the transferring of the shares by the Shares Purchase Agreement;

Decided:

1. To approve the transfer of OSHEE company shares (known before as CEZ Shpërndarje company), from CEZ a.s Company to the Ministry of Economic Development, Trade and Entrepreneurship.
2. Legal and Customer Protection Office is charged to notify the Ministry of Economy Development, Trade and Entrepreneurship and OSHEE company for ERE-s Board of Commissioner Decision.

This decision enters immediately into force.
