### DECISION

No. 94 of date 06.10.2014

#### FOR

#### LICENSING “KOMP.ENERGJI” COMPANY IN ELECTRICITY GENERATION ACTIVITY FROM “HURDHAS 1”, “HURDHAS 2” AND “HURDHAS 3” HPP-S WITH A TOTAL CAPACITY OF 4.21 MW.

On the basis of articles 8 point 2 letter “a”; 9 and 13 points 1, letter “a”, of Law No. 9072, date 22.05.2003, “For Electricity Sector”, as amended, articles 4 point 1 letter “a”; 5 point 1 letter “a”; 13 and 14 point 1 of the “Regulation for the procedures of licensing, modification, full/partial transferring and license renewal”, approved with Board of Commissioners Decision No. 108 of date 09.09.2008, ERE-s Board of Commissioners, on its meeting of date 06.10.2014, after reviewing the request of “KOMP.ENERGJI” company and the report of License and Market Monitoring Office as well as Legal and Customer Protection Office to license this company in Electricity Generation activity from, “Hurdhas 1”, “Hurdhas 2” and “Hurdhas 3” HPP-s.

#### Observed that:

The application of “KOMP.ENERGJI” company, fully completes the requirements provided by ERE in the “Regulation for the procedures of licensing, modification, full/partial transferring and license renewal” as follows:

- **General documentation** defined in: **article 9, points 1** (the application format); **Article 9, points 2** ( legal, administrative and ownership documentation); **Article 9, points 3** (financial and fiscal documentation) **is completed correctly.**

- **Technical documentation regarding the type of license** defined in: **Article 9, point 4.1.1 (Specific data for HPP); Article 9, point 4.1.2** (the data for the transformation block and connection with the system); **Article 9, point 4.1.3** (technical and graphic documentation) ; **Article 9, point 4.1.4** (Technical-economic documentation); **Article 9, point 4.1.5** ( Permission from other institutions), **is fully completed.**

For all the above mentioned ERE-s Board of Commissioners,

**Decided:**

1. To license “KOMP.ENERGJI” company, in Electricity Generation activity “Hurdhas 1” Hpp with a capacity of 1,71 MW, “Hurdhas 2” Hpp with a capacity of 1,3 MW and “Hurdhas 3” with a capacity of 1,2 MW, with a total capacity of 4.21 MW for a period of 30- years.
2. License and Market Monitoring Office shall notify the applicant for ERE-s Board of Commissioner Decision
