DECISION

No. 98 of date 27.10.2014

TO TERMINATE THE TEMPORARY ADMINISTRATION OF ELECTRICITY DISTRIBUTION SYSTEM OPERATOR (OSHEE) COMPANY

On the basis of article 9 and 18, point 5, of Law No. 9072, date 22.05.2003, "For Electricity Sector", as amended, Board of Commissioners Decisions no. 96 of date 27.10.2014 and no. 97 of date 27.10.2014, for licensing Electricity Distribution Operator company in electricity retail and wholesale distribution activities ERE-s Board of Commissioners, on its meeting of date 27.10.2014,

Observed that:

- According to Decision no.5 of date 21.01.2013, the Electricity Distribution and Electricity Retail Public Supplier activity is performed by Electricity Distribution Operator (OSHEE) company in temporary administration.
- With decisions no.96 date 27.10.2014 and no. 97 of date 27.10.2014, the Board of Commissioners decided to license Electricity Distribution Operator company in electricity distribution and retail public supplier activities,

For all the above mentioned ERE-s Board of Commissioners

DECIDED:

- 1. To terminate the temporary administration of Electricity Distribution System Operator (OSHEE) company, according to Board of Commissioners Decision no.5, of date 21.01.2013.
- 2. To abrogate the bylaws provided pursuant to Decision no.5, of date 21.01.2013.
