**BEGINNING THE PROCEDURES TO LICENSE “DRAGOBIA ENERGY”  
COMPANY IN ELECTRICITY GENERATION ACTIVITY FROM  
“CEREMI” AND “DRAGOBIA” HPP-s.**

On the basis of article 8 point 2 letter “a”, article 9 and article 13 point 1, letter “a”, of Law no. 9072, date 22.05.2003, “*For Power Sector*”, as amended, article 4, point 1, letter “a”, and article 10, points 1 and 3 of the “*Regulation for the Procedures of Licensing, Modification, Full/Partial Transferring and License Renewal*”, approved with Board of Commissioner Decision No. 108, of date 09.09.2008, article 18, point 1, letter “a”, of ERE-s *Practice and Procedure Regulations*, approved with Board of Commissioner Decision no. 21, of date 18.03.2009, as amended, ERE-s Board of Commissioners, on its meeting of date 01.12.2014, after reviewing the application submitted by “DRAGOBIA ENERGY” company and the report of License and Market Monitoring Directory as well as Legal and Customer Protection Directory to license this company in electricity generation activity,

**Observed that:**

The application of “DRAGOBIA ENERGY” company partially completes the requirements provided by ERE in the Regulation for the procedures of licensing,

modification, full/partial transferring and license renewal as follows:

- The application format (article 9, point 1) is submitted and completed correctly.
- Legal, administrative and ownership documentation (article 9, point 2) is submitted and completed partially.  
(The structure of administrative construction and functioning of the company is missing.)
- Financial, fiscal documentation is completed partially.  
(The documentation for attesting the Tax payment is missing)
- Technical documentation (Article 9, points 4.1.1; 4.1.2; 4.1.3;) are partially completed. (The technical data for the HPP-s from the applicant are incomplete. The technical data for the transformation block are incomplete,)
- Technical documentation Article 9, point 4.1.3 is completed correctly.
- Article 9, point 4.1.4 technical-economic documentation point *ë* is partially completed.  
(The feasibility study, the graph of implementing the project and the business plan is missing.)
- Permission from other institutions. (Article 9, point 4.4.5) is completed correctly.

For the missing documentation, the company will be informed that according to the “*Regulation for the Procedures of Licensing, Modification, Full/Partial Transferring and License Renewal*”, article 10, point 10 and article 11, point 1, to submit them at ERE, within the deadlines.

For all of the above mentioned ERE-s Board of Commissioners,

**Decided:**

1. To begin the procedures for reviewing the application of “DRAGOBIA ENERGY” company for licensing in electricity generation activity from “Ceremi” and “Dragobia” HPP-s with an installed capacity of “Ceremi” 8.6 MW and “Dragobia” 13.4 MW. The total capacity is 22 MW.
2. License and Market Monitoring Directory is charged to notify the applicant for ERE-s Board of Commissioner decision.

This decision enters immediately into force.
