DECISION

No. 1 of Date 19.01.2017

ON

OPENING THE PROCEDURE TO REVIEW AND APPROVE "THE ELECTRICITY MARKET RULES AND THE PARTICIPATION AGREEMENT IN THE POWER ORGANIZED EXCHANGE"

Based on articles 16; 19 letter "a" and 98 of Law No. 43/2015 "On Power Sector"; Council of Ministers Decision no. 519, of date 13.07.2016 "On approving the electricity market model"; as well as article 26 of the "Regulation on ERE Organization, Operation and Procedures ", approved with ERE Board Decision, no. 96, of date 17.06.2016, ERE Board on their 19.01.2017 meeting, after reviewing the report prepared by the Technical Directories regarding opening the procedures for approving "Albanian Electricity Market Rules" and "the Agreement for Participation in the power organized exchange",

Observed that:

- Based on article 98 of Law no. 43/2015, "On Power Sector": ERE, with the proposal of the Transmission System Operator and in cooperation with all power sector participants, in conformity with this law and the electricity market model.
- With Council of Ministers decision no. 519, of date 13.07.2016 it is decided "For the Approval of Electricity Market Model";
- TSO company with its official letter Protocol no. 7565, of date 12.12.2016, submitted at ERE for approval the draft "Rules for the Albanian Electricity Market" and the draft "Agreement for Participation in the power organized exchange."

Decided:

- **1.** To begin the procedure for the approval of the :
 - a) "Electricity Albanian Market Rules"
 - Products Specification Annex I
 - Albanian Market Rules for the Day Ahead Annex II
 - In-day Market Rules Annex III
 - Rules for Market Administration Annex IV
 - Rules for the Payment and Invoicing Annex V
 - Import/Export Area Annex VI
 - General Terms Annex VII,
 - b) The Agreement for Participation in the Albanian Power Exchange.
- 2. Legal and Customer Protection Directory shall inform OSHEE, KESH, TSO companies, the Ministry of Energy and Industry, the Competition Authority and the other interested parties for ERE Board decision.

This decision enters immediately into force.

This decision may be appealed at the Administrative Court of Tirana, within 30 calendar days, from the day of their publish in the Official Gazette.
