DECISION

No. 113, of September.22.2015

ON

BEGINNING THE PROCEDURES TO LICENSE "C&S ENERGY" COMPANY IN ELECTRICITY GENERATION ACTIVITY FROM "RAPUN 3 & 4" HPP-S WITH INSTALLED CAPACITY 8857 KW

Based on Law No.43/2015 articles 16, 37, point 2 letter "a" and article 110 "On Power Sector", the "Regulation for the Procedures of Licensing, Modification, Full/Partial Transferring and Licenses Renewal", articles 4, point 1, letter "a"; 5, point 1 letter "a"; 10 point 3, approved with ERE Board of Commissioners Decision, No. 108, date September.09.2008 and "ERE Practice and Procedure Regulation" article 18 point 1 letter "a", approved with ERE Board of Commissioners Decision no. 21 of March.18.2009, as amended, ERE Board on their September.22.2015 meeting, after reviewing the application submitted by "C&S ENERGY" company, and the report of License and Market Monitoring Directory as well as Legal and Customer Protection Directory to license this company in electricity generation activity from "Rapun 3 & 4" HPP,
