ON

BEGINNING THE PROCEDURES TO LICENSE "ENERGJIA D.O.O VETERNIK" COMPANY, IN ELECTRICITY TRADING ACTIVITY

Based on Law no. 43/2015 articles 16, 37, point 2 letter "d" and article "On Power Sector", the "Regulation for the Procedures of License, Modification, full/partial Transferring and Licenses Renewal", articles 4, point 1, letter "g"; 5, point 2; article 10, points 1 and 3, approved with ERE Board of Commissioners Decision No. 108, of September.09.2008 and "ERE Practice and Procedure Regulation" article 18 point 1 letter "a", approved with ERE Board of Commissioners decision no. 21 of March.18.2009, as amended ERE Board on their October.14.2015 meeting, after reviewing the application submitted by "Energjia D.O.O Veternik" company, and the report of License, Market and Licensee Monitoring Directory as well as Legal and Customer Protection Directory to license this company in electricity trading activity;
