#### DECISION

No. 126, of October.29.2015

### ON

# BEGINNING THE PROCEDURES TO LICENSE "UJANIKU ENERGY" COMPANY IN ELECTRICITY GENERATION ACTIVITY FROM "UJANIK 2" HPP WITH INSTALLED CAPACITY 2.5 MW

Based on Law No.43/2015 articles 16; 37, point 2 letter "a" and article 110 "On Power Sector", the "Regulation on the Procedures of License, Modification, full/partial Transferring and Licenses Renewal" articles 4, point 1, letter "a"; 5, point 1 letter "a"; 10 point 3, approved with ERE Board Decision, No. 108, of September.09.2008 and "ERE Practice and Procedure Regulation" article 18 point 1 letter "a", approved with ERE Board of Commissioners decision no. 21 of March.18.2009, as amended, ERE Board on their October.29.2015 meeting, after reviewing the application submitted by "Ujaniku Energy" company, and the report of License, Market and Licensee Monitoring Directory as well as Legal and Customer Protection Directory for licensing this company in electricity generation activity from "Ujanik 2" HPP,

### Observed that:

The application of "Ujaniku Energy" company, partially completes the requirements provided by ERE in the "Regulation for the procedures of license, modification, full/partial transferring and licenses renewal" as follows:

- The application format (article 9, point 1) is completed correctly.
- Legal, administrative and ownership documentation (articles 9, point 2) is submitted correctly.

- Technical-economical documentation (article 9, points 4.1.1; 4.1.2; 4.1.4; 4.1.5)

### For the missing documentation, that has to do with:

• Technical-economical documentation (article 9, point 4.1.3), (the general appearance of the schematic plant, the electrical diagram of the aggregates as well as the geographical extension of the country where plant will be constructed.), the company will be informed that on the basis of the "Regulation for the Procedures of Licensing, Modification, full/partial Transferring and Licenses Renewal", article 10, point 10 and article 11, point 1, to submit these documents at ERE within the deadlines.

For all of the above mentioned, ERE Board,

### Decided:

- 1. To begin the procedures of licensing "Ujaniku Energy" company, in electricity generation activity from "Ujaniku 2" HPP with installed capacity 2.5 MW.
- 2. License, Market and Licensee Monitoring Directory shall inform the applicant for ERE Board Decision.
