DECISION

No. 128, of October.29.2015

ON

BEGINNING THE PROCEDURES TO LICENSE "STRELCA ENERGY" COMPANY IN ELECTRICITY GENERATION ACTIVITY FROM "STRELCA 1" HPP WITH INSTALLED CAPACITY 1504 KW, "STRELCA 2" HPP WITH INSTALLED CAPACITY 325 KW AND DHE "STRELCA 3" HPP WITH INSTALLED CAPACITY 3520 KW (TOTAL INSTALLED CAPACITY 5349 KW)

Based on Law no. 43/2015 article 16; 37, point 2 letter "a" and article 110 "On Power Sector", the "Regulation for the Procedures of License, Monitoring, full/partial Transferring and Licenses Renewal" articles 4, point 1, letter "a"; 5, point 1 letter "a"; 10 point 3, approved with ERE Board of Commissioners Decision, No. 108, of September. 09.2008 and "ERE Practice and Procedure Regulation" article 18 point 1 letter "a", approved with ERE Board of Commissioners decision no. 21 of March.18.2009, as amended, ERE Board on their October.29.2015 meeting, after reviewing the application submitted by "STRELCA ENERGY" company, and the report of License, Market and Licensee Monitoring Directory as well as Legal and Customer Protection Directory to license this company in electricity generation activity from "Strelca 1", "Strelca 2" and "Strelca 3" HPP-s,

Observed that:

The application of "STRELCA ENERGY" company partially completes the requirements provided by ERE in the "Regulation for the procedures of license, modification, full/partial transferring and licenses renewal" as follows:

- The application format (article 9, point 1) is completed correctly.
- Technical-economical documentation (article 9, points 4.1.4 and 4.1.5), is completed correctly.

- Financial and fiscal documentation (article 9, point 3);
- Technical-economical documentation (article 9, points 4.1.1, 4.1.2, 4.1.3),

The company will be informed that on the basis of the "Regulation for the Procedures of Licensing, Modification, full/partial Transferring and Licenses Renewal", article 10, point 10 and article 11, point 1, to submit these documents at ERE, within the deadlines.

For all of the above mentioned, ERE Board,

Decided:

- 1. To begin the procedures of licensing "STRELCA ENERGY" company, in electricity generation activity from "Strelca 1" HPP with installed capacity 1504 kW, "Strelca 2" HPP with installed capacity 325 kW and "Strelca 3" HPP, with installed capacity 3520 kW. (total installed capacity 5349 kW)
- 2. License, Market and Licensee Monitoring Directory shall inform the applicant for ERE Board Decision.
