#### **DECISION**

No. 13, of February.16.2016

## ON

# THE ELECTRICITY FIX TARIFF THAT WILL BE PAID TO ELECTRICITY GENERATORS FROM THE HYDRO POWER PLANTS FOR 2016

Based on Law no. 43/2015 article 16, "On Power Sector", Law no. 138/2013 "On Energy renewable resources" article 15 point 3, as amended, Council of Ministers Decision no. 1033 of December.16.2015 "On approving the methodology of defining the fix electricity tariff, that shall be paid to electricity generators from the hydro power plants" as well as point 3 of ERE Board of Commissioners Decision no.156, of December.24.2015, ERE Board on their February.16.2016 meeting, after reviewing the report of Technical Directories on electricity fix tariff that will be paid to electricity generators from the hydro power plants for 2016, as well as the required additional information,

# Observed that:

- Council of Ministers Decision no.1033, of December.16.2015, has approved the Methodology of defining the electricity fix tariff that shall be paid to electricity producers from the Hydro Power Plants" where it is defined that the "Sale Price (ALL/kWh) = the average price for the respective year of the Hungarian exchange (HUPX) for electricity in euro cent/kWh X the coefficient 1.24 X the average exchange norm in euro/ALL for the last year.
- Annual report (Physical futures Annual report) from the Hungarian exchange HUPX for the respective year is published.

- ERE Board on point 3 decision no. 156 of December.24.2015 has defined that, after the publication of the Annual report (Physical Futures Annual Report) from the Hungarian exchange HUPX for the respective year, as defined in council of ministers decision (VKM) no.1033, of December.16.2015, ERE shall express with decision "On approving the fix electricity tariff for 2016, to electricity generators from the hydro power plants".
- ERE Board on point 2 decision no. 156 of December.24.2015, has defined that: The legal power of ERE Board Decision no. 27, of February.16.2015 "On approving the electricity fix tariff for 2015, that will be paid to electricity generators from hydro power plants, is extended until taking the decision to repeal it by ERE Board

For all of the above mentioned ERE Board,

## Decided:

- **1-** The electricity fix tariff that shall be paid to electricity producers by hydro power plants for 2016 shall be 7.448 ALL/kWh.
- **2-** With the entry into force of this decision, it is repealed ERE Board of Commissioners decision no. 27 of February.16.2015, "On approving the electricity fix tariff for, that shall be paid to electricity generators from the hydro power plants.
- **3-** The differences that may result, between the approved price for 2016 and the approved price for the intermediate period with ERE Board decision no. 156 of December.24.2015, shall be arranged by correcting the respective invoices.
- **4-** Tariff and Prices Directory shall inform the interested parties for ERE Board decision.

This decision enters immediately into force and extends its effects from January.1.2016.
