DECISION

No. 14 date, February.11.2015

ON THE REQUEST OF OST (TRANSMISSION SYSTEM OPERATOR) COMPANY FOR REVIEWING AND SUSPENDING DECISION NO. 156, DATE DECEMBER.01.2014 OF ERE BOARD OF COMMISSIONERS ON APPROVING THE AUCTION REGULATIONS FOR THE COORDINATED AUCTION OFFICE OF SOUTHEAST EUROPE (SEE CAO)".

On the basis of Law no.9072 date May.22.2003, "On Power Sector" as amended article 9, "ERE Practice and Procedures Rules" article 16 point 3 approved with Decision No.21 date March. 18.2009, as amended, the Board of Commissioners, on their February.11.2015 meeting, after reviewing the request of OST (Transmission System Operator) company to review and suspend ERE Board of Commissioners decision no.156 of December.01.2014 for "Approving the Auction Regulations for the Coordinated Auction Office of South East Europe (SEE CAO)" as well as the report prepared by the Legal and Customer Protection Directory;

Observed that:

- The regulation is drafted in conformity with the requests of Regulation (EC) 714/2009 of the European Parliament.
- On the quality of ECRB Member States it is recommended that National regulators, members of ECRB to approve this regulation.
- There are no other proves that can lead ERE Board of Commissioners in taking a decision that ERE has now taken.
