#### **DECISION**

No. 18, of date 31.01.2017

### **ON**

OPENING THE PROCEDURE TO REVIEW AND APPROVE THE EELCTRICIY SALE-PURCHASE CONTRACT BETWEEN KESH AND OSHEE COMPANIES FOR ELECTRICITY SURPLUSES INCLUDING THOSE IN CONDITIONS OF LARGE FLOWS FOR FULFILLING THE LOSSES IN THE DISTRIBUTION SYSTEM FOR 01.01.2017-31.12.2017 PERIOD

Based on article 16 of Law No. 43/2015, "On Power Sector", Article 5 point 4 of the Council of Ministers Decision no. 244 of date 30.03.2016, "On approving the conditions for imposing public service obligation that shall be implemented to the licensee on power sector that exercise the electricity generation, transmission, distribution and electricity supply activities", and article 26 of the "Rules on ERE organization, operation and procedures, approved with ERE Board decision No. 96 of date 23.06.2016, ERE Board on their 31.01.2017 meeting after reviewing the report prepared by ERE Technical Directories on opening the procedure to approve the electricity sale-purchase agreement between KESH and OSHEE companies for the electricity surpluses including those in the conditions of large flows for fulfilling the losses in the distribution system for 01.01.2017-31.12.2017 period,

#### Observed that:

- With ERE Board decision No. 174, of date 07.11.2016 it is agreed the approval of electricity sale-purchase contract/agreement between KESH and OSHEE companies for the electricity surpluses, including those in the conditions of large flows for fulfilling the losses in the distribution system for 01.07.2016-31.12.2016 period,
- "OSHEE" company with the official letter protocol no. 31126, of date 23.12.2016 has send to KESH company to sign the electricity sale-purchase agreement/Contract between KESH and OSHEE for the electricity surpluses including those in the conditions of large flows, for fulfilling the losses in the distribution system for 01.01.2017-31.12.2017 period.

- "KESH" company with the official letter Protocol no. 88 of date 09.01.2017 has send to OSHEE company to sign the electricity sale-purchase agreement/Contract between KESH and OSHEE company for the electricity surpluses, including those in the conditions of large flows, for fulfilling the losses in the distribution system for 01.01.2017-31.12.2017 period.
- This agreement with KESH company identification Protocol no. 87 of date 09.01.2017 and OSHEE protocol no. 1306 of date 17.01.2017 is signed by both parties.
- It was observed that the amendments in this agreement, referring to the content of the previously agreed agreement with ERE Board decision no. 174, of date 07.11.2016, are only in the function of the regulatory framework update previously approved by ERE with the above mentioned decision.

For all of the above mentioned ERE Board,

#### Decided:

- 1. To open the procedure of reviewing and approving the electricity sale-purchase Contract/Agreement between KESH and OSHEE companies for the electricity surpluses, including those in the conditions of large flows, for fulfilling the losses in the distribution system for 01.01.2017-31.12.2017 period.
- **2.** Legal and Customer Protection Directory shall inform the interested parties for ERE Board decision.

This decision enters immediately into force.

This decision is published in the Official Gazette.

This decision may be appealed at Tirana Administrative Court, within 30 calendar days from the publication in the Official Gazette.
