



DECISION

No.1 date February .02.2015

ON APPROVING THE AGREEMENT BETWEEN KESH (ALBANIAN POWER CORPORATION) COMPANY AND OST (TRANSMISSION SYSTEM OPERATOR) COMPANY FOR ELECTRICITY SALE-PURCHASE TO COVER THE TECHNICAL LOSSES IN THE TRANSMISSION SYSTEM, FOR 2015.

Based on Law 9072, date May.22.2003 "On Power Sector" (as amended) article 8 point 2, article 9, and 26, point 1, article 35, point 1, letter b and point 2, letter b, as well as article 41, point 3 letter ç, the "*Electricity Market Model*" point 4.13, letter (a), point 8, point 5.2, (ii) and point 7 letter (f) approved with Council of Ministers Decision no.338, date March.19.2008, as amended, the *Electricity Market Rules* Chapter V approved with ERE Board of Commissioners Decision, no. 68 date June.23.2008, as amended, ERE Board of Commissioners on their February. 02.2015 meeting, after being introduced with the report submitted by ERE Technical Directories, on the contract "For electricity sale and purchase to cover the technical losses in the transmission system" for 2015 between KESH (Albanian Power Corporation) company and OST (Transmission System Operator) company;

Observed that:

- 1. The parties of this contract are legal companies legitimated to sign the agreement "For electricity sale and purchase to cover the technical losses in the transmission system" taking into account that:
- KESH (Albanian Power Corporation) company in licensed in electricity generation activity with ERE Board of Commissioners Decision, No. 23 date June.23.2009 as amended.
- OST (Transmission System Operator) company is licensed in Electricity Transmission activity with ERE Board of Commissioners Decision, No. 24, date March.26.2009

2. This contract provisions are in harmony with the *Electricity Market Model* approved with Council of Ministers Decision no. 338 date March.19.2008, and *the Market Rules* approved with Board of Commissioners Decision no. 68, date June.23.2008, as amended.

For all of the above mentioned ERE Board of Commissioners,

Decided:

- 1. To approve the "*Electricity sale-purchase agreement to cover the technical losses in the transmission system*" for 2015 between KESH (Albanian Power Corporation) company and OST (Transmission System Operator) company.
- 2. Legal and Customer Protection Directory shall inform the parties for this decision.

This decision enters immediately into force and extends its effects from January.01.2015 until on December.31.2015.
