FOR BEGINNING THE PROCEDURES TO LICENSE "KOXHERI ENERGJI" COMPANY, IN ELECTRICITY GENERATION ACTIVITY FROM "KOXHERAJ" HPP WITH TOTAL CAPACITY OF 0.62 MW.

On the basis of Law 9072 of May.22.2003 "On Power Sector", as amended, article 8 point 2 letter "a", article 9 and article 13 point 1, letter "a", the "Regulation for the Procedures of Licensing, Modification, Full/Partial Transferring and License Renewal "article 4, point 1, letter "a", and article 10, point 1 and 3", approved with Board of Commissioners Decision No. 108, of September.09.2008, article 18, point 1, letter "a", of ERE-s Practice and Procedure Regulations, approved with Board of Commissioners Decision no.21, of March.18.2009, as amended, ERE Board of Commissioners on their March.04.2015 meeting, after reviewing the application submitted by "KOXHERI ENERGJI" company and License and Market Monitoring Directory as well as Legal and Customer Protection Directory to license this company in electricity generation activity from "Koxheraj" HPP,
