DECISION

No.34 Date, March.04.2015

FOR BEGINNING THE PROCEDURES TO LICENSE "ALPIQ ENERGY ALBANIA" COMPANY, IN THE ACTIVITY OF ELECTRICITY QUALIFIED SUPPLIER.

Based on Law 9072, date May.22.2003, "On Power Sector" as amended, articles 3, point 31; 8 point 2, letter "a"; 9; 13 point 1 letter "ç"; 45 points 3, 4 and 48, the "Regulation for the procedures of licensing, modification, full/partial transferring and licenses renewal" articles 4 point 1 letter "f"; 5 point 1 letter "f" 8; 10, point 1 and 3 approved with Board of Commissioners Decision No. 108 date September.09.2008, the "ERE Practice and Procedure Regulation" article 18, point 1, letter "a", approved with Board of Commissioners Decision, No. 21, date March.18.2009, as amended, ERE Board of Commissioners, on their March.04.2015 meeting, after reviewing the application submitted by "ALPIQ ENERGY ALBANIA" company, and the report of License and Market Monitoring Directory as well as Legal and Customer Protection Directory to license this company in the activity of Electricity Qualified Supplier,
