No. 66 Date May.11.2015

FOR

BEGINNING THE PROCEDURES TO LICENSE "GAMA ENERGY" COMPANY IN ELECTRICITY GENERATION ACTIVITY FROM "LENA 1", "LENA 2" AND "LENA 2A" WITH INSTALLED CAPACITY RESPECTIVELY 1.95 MW; 2.3 MW AND 0.25 MW (TOTAL CAPACITY 4.5 MW).

Based on Law No.9072, date May.22.2003, "On Power Sector" as amended, articles 8 point 2 letter "a"; 9 and 13 point 1, letter "a" as amended, the "Regulation for the Procedures of Licensing, Modification, full/partial Transferring and Licenses Renewal", approved with Board of Commissioners Decision No.108, date September.09.2008, ERE Board of Commissioners on their May.11.2015 meeting, after reviewing the application submitted by "GAMA ENERGY" company, and the report of License and Market Monitoring Directory as well as Legal and Customer Protection Directory to license this company in electricity generation activity from "Lena 1", "Lena 2" and "Lena 2A" HPP-s.

Observed that:

The application of "GAMA ENERGY" company, completes the requirements provided by ERE in the "Regulation for the procedures of licensing, modification, full/partial transferring and licenses renewal" as follows:

Article 9, point 3 Financial and fiscal documentation is fully completed.

For the missing documents, the company will be informed that on the basis of the "Regulation for the Procedures of Licensing, Modification, full/partial Transferring and Licenses Renewal", article 10, point 10 and article 11, point 1, to submit these documents at ERE, within the deadlines.

For all of the above mentioned ERE Board of Commissioners,

Decided:

- 1. To begin the procedures of licensing "GAMA ENERGY" company, in electricity generation activity from "Lena 1", "Lena 2" and "Lena 2A" HPPs with installed capacity respectively 1.95 MW; 2.3 MW and 0.25 MW (total capacity 4.5 MW).
- 2. License and Market Monitoring Directory shall inform the applicant for ERE Board of Commissioners Decision.
