ON

THE REQUEST OF OST (TRANSMISSION SYSTEM OPERATOR) COMPANY TO REVIEW AND SUSPEND DECISION NO. 141, DATE DECEMBER.26.2014 OF ERE BOARD OF COMMISSIONERS “TO DETERMINE THE ANCILLARY SERVICE TARIFF FOR 2015”

Based on Law 9072, date, May.22.2003, “On Power Sector” (as amended) article 9 and ERE Practice and Procedure Rules article 16 point 3, approved with Decision no. 21, date March.18.2009, ERE-s Board of Commissioners on their **February.02.2015**, meeting, after being informed with the report prepared by Technical Directories on the request of OST (Transmission System Operator) company to review and suspend ERE Board of Commissioners Decision no. 141 date December.26.2014 “ For determining the ancillary service tariff for 2015”,

Observed that:

- The way of distributing the costs in the power system is ERE-s discretion which is obliged by law to cover all the necessary costs for the regulated market sections, for its well-functioning.
- The ancillary service tariff is applied for the first time and is considered at the experimental phase.
- It is left the task that, within the first quarter of 2015 to be reviewed within the parties the accuracy of calculating and testing the application of this tariff.

For all of the above mentioned ERE Board of Commissioners;

Decided:

1. To not accept the OST (Transmission System Operator) company request for reviewing and suspending decision no.141 date December.26.2014 of ERE Board of Commissioners “For defining the ancilliary service tariff for 2015” as unfounded on new evidences that may lead ERE Board of Commissioners to take a decision different from the one taken on Decision no.141, date December.26.2014.
2. To let into force of decision no. 141 date December.26.2014 of ERE Board of Commissioners “To define the ancillary services tariff for 2015”.
3. Legal and Customer Protection Directory is charged to inform OST (Transmission System Operator) company for ERE Board of Commissioners Decision.

This decision enters immediately into force.
