BEGINNING THE PROCEDURES TO LICENSE KABASH POROCAN HPP IN ELECTRICITY GENERATION ACTIVITY FROM – ET "HOLTA KABASH" AND "HOLTA POROCAN" HPP-s WITH INSTALLED CAPACITY RESPECTIVELY 2.2 MW AND 3.3 MW, (TOTAL CAPACITY 5.5 MW)

Based on Law 9072, date May.22.2003 "On Power Sector" as amended articles 8 point 2 letter "a"; 9 and 13 point 1, letter "a", the "Regulation for the Procedures of Licensing, Modification, full/partial Transferring and Licenses Renewal" articles 4, point 1, letter "a", and 10, point 1 and 3, approved with Board of Commissioners Decision No. 108, date September.09.2008, "ERE Practice and Procedures Regulation" article 18, point 1, letter "a", approved with Board of Commissioners Decision no. 21, date March.18.2009, as amended, ERE Board of Commissioners, on their June.08.2015 meeting, after reviewing the application submitted by "KABASH POROCAN HPP" company, and the report of License and Market Monitoring Directory as well as Legal and Customer Protection Directory to license this company in electricity generation activity,
