**ON APPROVING THE AGREEMENT BETWEEN KESH  
(ALBANIAN POWER CORPORATION) COMPANY AND OST  
(TRANSMISSION SYSTEM OPERATOR) COMPANY FOR  
ENSURING THE ANCILLARY AND BALANCING SERVICES OF  
THE ELECTRICITY SYSTEM.**

Based on Law 9072, date May.22.2003, “*On Power Sector*” (as amended) article 8 point 2, article 9, 26, point 1; article 35, point 1, letter b and point 2, letter b, and article 41, point 3, letter ç), the *Electricity Market Model* article 5.2 (i) and point 7 letter (f), paragraph 4, approved with Council of Ministers Decision no.338, date March.19.2008, as amended, Chapter V of *Electricity Market Rules* approved with ERE Board of Commissioners Decision, no. 68 date June.23.2008, as amended, ERE Board of Commissioners on their February.04.2015 meeting, after being informed with the report prepared by ERE-s Technical Directories, on the contract “*For ensuring the ancillary and balancing services of the electricity system*” for 2015 between KESH (Albanian Power Corporation) company and (Transmission System Operator) company;

**Observed that:**

1. The parties of this agreement are legal companies legitimated to sign the agreement “*To ensure the ancillary and balancing services in the electricity system*” should be taken into account that:
  - KESH (Albanian Power Corporation) company is licensed in electricity generation activity with ERE Board of Commissioners Decision, No. 23, date March.25.2009.
  - OST (Transmission System Operator) company is licensed in Electricity Trading activity with ERE Board of Commissioners Decision, No. 24, date March.26.2009
2. The agreement is signed by both parties.

For all of the above mentioned ERE Board of Commissioners,

**Decided:**

1. To approve the agreement “For ensuring the ancillary and balancing services in the electricity system”, for 2015.
2. Legal and Market Monitoring Directory is charged to inform the parties for this decision.

This decision enters immediately into force and extends its effects from January.01.2015 until December.31 .2015.
