



# DECISION

### No. 19, of date 31.01.2017

#### ON

# OPENING THE PROCEDURE TO LICENSE "ENERGJI UNIVERS" COMPANY IN ELECTRICITY GENERATION ACTIVITY FROM "KABASH" HPP WITH INSTALLED CAPACITY **5.8** MW.

Based on articles 16, 37, point 2 letter "a" of Law No. 43/2015 "On Power Sector", articles 4, point 1, letter "a"; 5, point 1 letter "a"; 10 point 1 and 3, of the "Regulation on the procedures and deadlines for license issue, modification, transferring, renewal and license removal on power sector", approved with ERE Board Decision, No. 109, of date 29.06.2016, and article 19 point 1 of "ERE Organization, Operation and Procedures Rules", approved with Board decision no.96, of date 17.06.2016, ERE Board on their 31.01.2017 meeting after reviewing the application submitted by "ENERGJI UNIVERS" company and the report of License and Market Monitoring Directory on licensing this company in electricity generation activity,

#### Observed that:

The application of "ENERGJI UNIVERS" company, partially completes the requirements of ERE in the "Regulation on the procedures and terms on license issue, modification, transferring renewal and license removal on power sector" as follows:

- The application form (article 9, point 1, letters "a", "b", "c") is completed correctly;
- Legal, administrative and ownership documentation (article 9, point 2 letters "a", "b", "c", "e", "f", "g") is completed correctly;
- Financial and fiscal documentation (article 9, point 3 letters "b", "c", "d") is completed correctly;

• Technical documentation (article 9, points 4.1.1; 4.1.2; 4.1.3; 4.1.4; 4.1.5) is completed correctly.

Regarding the missing documentation that has to do with:

- The certification from the Court and the Prosecution, (article 9, point 2 letter "d");
- Certification for Tax liquidation (article 9, point 3 letter "a"); the company shall be informed that based on the "Regulation on the procedures and terms for license issue, modification, transferring renewal and license removal on power sector" to submit them at ERE, within the defined deadlines.

For all of the above mentioned ERE Board,

# Decided:

- To open the procedure of licensing "ENERGJI UNIVERS" company in electricity generation activity from "Kabash" HPP with installed capacity 5.8 MW.
- 2. License and Market Monitoring Directory shall inform the applicant for ERE Board Decision.

This decision enters immediately into force. This decision is published in the Official Gazette.

This decision may be appealed at Tirana Administrative Court, within 30 calendar days from the publication in the Official Gazette.
